Students who are selected for verification must complete the verification process (submit all required forms and have the ISIR corrected) within 120 days of their last day of attendance or by the date specified by USDE for the award year, whichever comes first. If the student does not complete verification within the time frame the student will not qualify for Title IV at this institution.

NOTE: If you do not turn the documentation in to your school within 30 days, you may need to pay cash to attend school until verification is completed. The school may take into account extenuating circumstances on this 30 day deadline.
